# Benedict Advertising & Marketing Report

Mr. Benedict presented the theme for new marketing campaign. Mr. Otte discussed the advertising opportunities for the new campaign. Ms. Browder discussed how the new campaigns will work well with Artificial Intelligence and automated technologies.

# Executive Director's Report: July 2023.

Ms. Turner stated the majority of the time since the last board meeting has been finalizing the budget and marketing plan, but it has been a busy couple of weeks.

Ms. Turner presented an overview of recent events and meetings:

EVENTS: Launched the CoolCraft Summer Beverage Competition June 23 and since then Marketing Coordinator David Swanberg has been taking our Flamingo mascot "Dougie" out and about doing reels and other promotions (which he played for the Board). WVTAA has had more than 60 signups for Bandwango and more than 200 votes since the contest began. Flamingo Magazine will be here later this month to judge the top vote-getters. Staff also attended the press conference and celebration for the first Avelo flight coming in from New Haven, CT on June 22. On Sunday, July 16, Ms. Turner welcomed the ST479 Tiger back to DeLand. The tugboat has been in Astor for the last couple of months. Lots of good local publicity on her return, but no word on where she'll end up.
