Benedict Advertising & Marketing Report

Mr. Otte presented an update on digital campaigns, website analytics, social media results and public relations for August 2023. Google Search & Display ad campaigns totaled 359,125 impressions, 7,727 clicks = 2.15% click through rate. The average view rate for video ads = 61.56%. Total website users were 16,893, and top pages are attractions, outdoor activities and calendar of events.

Mr. Otte reported on Facebook and Pinterest insights. Facebook lead generation for newsletter sign ups climbed to 769. Pinterest ads continue to do well. The open rate for the September newsletter was 33.51%.

Public Relations included coverage on Blue Spring State Park, Hotel Cassadaga and the CoolCraft Trail Summer Beverage Competition.
